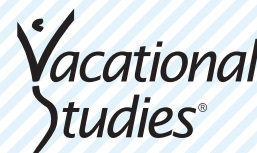

- * Flights should depart between 11.00 and 14.00 with check-in no earlier than 09.30 and no later than 14.00. Parents must safeguard children after our contract ends at 15.00.
- Arrival direct at the School should be between 12.30 and 14.30.
- Collection from the School should be before 11.00.
- To comply with legal UK Safeguarding regulations regarding the care of under-18s, we are not permitted to let under-18s remain at the airport unaccompanied by an adult, even with parental permission, after our contract ends at 15.00 on 8 August.
- These sections are ONLY for Heathrow arrivals/departures outside our requested times, using airports other than Heathrow, arrivals/departures on other dates and any other special requests. All special arrangements are at cost. We do not charge for our work in making arrangements.

7 These sentences may not be deleted. If you do not agree, we shall make special arrangements which may be at cost.

8 Everyone must leave the School by 13.00 on the last day. We shall make special arrangements (which may be at cost) for students travelling UM/YYP (Unaccompanied Minor). If a flight taken by a UM departs after 15.00, we ask that the flight be booked for the day before the last day of the Course. Parents must ensure documents are in order.
